PRESENTATIONS

AGRICULTURE – FAMILY & CONSUMER SCIENCES – GENERAL PRESENTATIONS

I. Eligibility

- A. Read General Rules
- B. 4-H members may participate in any of the following three areas:

<u>Agriculture Projects</u> – Members currently enrolled in Animal Science, Horticulture, Agronomy or Natural Science projects (includes Shooting Sports).*

<u>Family & Consumer Sciences Projects</u> – Members currently enrolled in Home Economics (clothing, foods, food preservation, housing), Consumer Education or Family Life projects.*

<u>General Projects</u> – Members should be enrolled in Engineering, Personal Growth and Development, Creative Arts or Arts and Crafts projects.*

*Refer to the 4-H Project Literature Materials Short List (200.B-3B) for a complete list of specific projects in each area.

- C. An <u>unlimited number of contestants from each county</u> may participate in each of these three contest areas.
- D. Presentations in each area may be entered by an individual or a two-person team. Team and individual presentations will be judged on the same criteria and will be competing against one another (there are <u>not</u> separate team and individual categories).

II. Procedures

- A. Presentations must be at least 10 minutes in length, but no longer than 15 minutes. Set up is limited to a maximum of 5 minutes and is <u>not</u> included in the presentation length. Time for answering questions is <u>not</u> counted in the presentation length. One point will be deducted for each minute or fraction of a minute <u>under</u> 10 minutes or <u>over</u> 15 minutes.
- B. Scoring for presentations will be done according to the established score sheet.
- C. Posters/charts/power point slides must be made by the presenter. During

judging, the content of the message, neatness, readability, accuracy, type of illustrative materials, and the effectiveness of the posters or charts as teaching tools will be considered.

- D. Contestant order will be determined by random drawing at the time of the contest.
- E. Participants should dress appropriately for the type of presentation.
- F. Contestants may use notes, however, excessive use of notes may be counted against the contestant at the discretion of the judges.
- G. Contestants are responsible for bringing equipment, supplies and visual aids. This includes a power point projector, computer and screen, unless special arrangements are made a minimum of 2 weeks prior to the contest. It is Recommended to also have presentation on a flash drive as backup.
- H. Following each presentation, only the judges will be allowed to ask participants questions directly related to the area of the presentation, their public speaking experience or their overall 4-H participation.
- I. In the event a team presentation receives an award, all awards must be divided equally between the two team members.
- J. Contestants will speak in front of the audience present in the room.
- K. Ties will be broken by the judges.

IV. Awards

First through fifth place ribbons will be awarded in each area. A special award will also be awarded in each area to the 1st place individual/team if they have an average score of at least 80 points.

The highest scoring presentation on a <u>horse topic</u> with the judges' recommendation is eligible to go on to the Western 4-H Roundup in Denver.
